PUBLIC NOTICE OF REVISION OF THE LIST OF ELECTORS

Notice is given to electors of Montréal that:

The list of electors was filed with the city archives on September 23, 2021. It is subject to revision before being used for the general election.

To be an elector and qualify for entry on the list of electors, every person must:

- be an individual
- be 18 or over on **November 7, 2021**
- and, on September 1, 2021,
- be a Canadian citizen
- not be under curatorship
- not be disqualified under the law

Every person must also meet one of the following conditions:

 have been domiciled on the territory of Montréal on September 1, 2021, and in Québec since at least March 1, 2021;

- have been the sole owner of an immovable on the territory of Montréal since at least September 1, **2020**, and have filed a written application for entry with the returning officer,

- have been the sole occupant of a business establishment on the territory of Montréal since at least September 1, 2020, and have filed a written application for entry with the returning officer.

Where an immovable belongs to undivided co-owners or where a business establishment is occupied by cooccupants, no person other than the undivided co-owner or the cooccupant designated under a power of attorney signed by the majority of co-owners or co-occupants who are electors, may be entered on the list of electors as owner of the immovable or co-occupant of the business establishment. The power of attorney must be filed with the returning officer.

A person who is an elector in more than one capacity may be entered on the list of electors in only one capacity, in the following order of precedence:

- as a domiciled person
- as the sole owner of an immovable

- as the sole occupant of a business establishment
- as the undivided co-owner of an immovable
- as the co-occupant of a business establishment

No person may be entered at more than one place on the list of electors of Montréal.

You may submit a written application for entry, correction or striking from the list of electors to the returning officer if you are domiciled in the municipality and you are in one of the following situations:

- You are domiciled or lodged in an eligible health establishment1;
- You are unable to travel for health reasons or you are a caregiver domiciled at the same address as such a person.
- Between Sunday, October 17, 2021, and Wednesday, October 27, 2021, you must comply with an order or recommendation for isolation from public health authorities because you:
 - returned from a trip abroad within the last 14 days;
 - were diagnosed with COVID-19 and you are still considered a carrier of the disease;
- are showing COVID-19 symptoms;
- have been in contact with a suspected, probable or confirmed case of COVID-19 within the last 14
- are waiting for a COVID-19 test result.

You must submit your application no later than October, 18 th, 2021 at 7 p.m.

This application must be accompanied by a copy of two documents: one showing your name and date of birth and the other showing your name and domiciliary address. If you are domiciled or you lodged in an eligible health establishment1, these documents may be replaced by an attestation from a staff member confirming your identity and place of residence.

If you are in one of the above-described situations, and you are entered on the list of electors, you can also vote by mail. To do this, you must make a verbal or written request to the returning officer no later than October 27, 2021.

If you are requesting to vote by mail because you must comply with an order or a recommendation from public health authorities to isolate, your request will be valid for the current poll only. If you are in a situation other than those above, your application will be valid for the current poll and any recommenced proceedings arising from this election.

The forms can be sent upon request and are available on the elections.montreal.ca website.

Eligible health establishment are hospital centres, CHSLDs, rehabilitation centres and private seniors' residences listed in the register established under the Act respecting health services and social services (chapter S-4.2) and hospital centres or reception centres within the meaning of the Act respecting health services and social services for Cree Native persons (chapter S-5).

IMPORTANT

Where an application for entry of a person domiciled on the territory of Montréal is filed, the person who files the application with a board of revisors must specify the previous address of the person concerned, and produce two documents: one confirming his name and date of birth, and the other, his name and present home address.

You may consult the list of electors and file applications for entry, correction or striking off with the board of revisors of your choice, on the following dates and times:
