

## BY-ELECTION • SUNDAY, DECEMBER 17, 2023 Borough Mayor of L'Île-Bizard–Sainte-Geneviève

### PUBLIC NOTICE OF REVISION OF THE LIST OF ELECTORS

Notice is given to the electors of the borough of L'Île-Bizard–Sainte-Geneviève that:

The list of electors was deposited with the Service du greffe de la Ville de Montréal (Élections Montréal) on November 6, 2023. It will be revised before being used in the by-election.

To be eligible to vote and be entered on the list of electors, a person must:

- Be a natural person
- Be 18 years of age or older **on December 17, 2023**

**and, as of October 30, 2023,**

- Be a Canadian citizen
- Not be in curatorship
- Not be legally incapacitated.

**All persons must also meet one of the following conditions:**

- Be domiciled in the borough of L'Île-Bizard–Sainte-Geneviève **on October 30, 2023**, and domiciled in Québec **since April 30, 2023 or earlier;**

**or**

- Be the sole owner of a property located within the territory of the borough of L'Île-Bizard–Sainte-Geneviève **since April 30, 2023 or earlier**, and have sent a written application for registration to Élections Montréal; **or**
- Have been the sole occupant of a business establishment located on the territory of the borough of L'Île-Bizard–Sainte-Geneviève **since October 30, 2022 or earlier**, and have sent a written application to Élections Montréal.

In the case of a property owned by undivided co-owners or a business establishment occupied by co-occupants, only the undivided co-owner or co-occupant designated by means of a proxy signed by the majority of co-owners or co-occupants entitled to vote has the right to be entered on the list of electors as owner of the property or occupant of the business establishment. This proxy must be delivered to Élections Montréal.

A person who is an elector in more than one capacity may be entered on the list of electors in only one of these capacities, according to the following order of priority:

- As a domiciled person;
- As sole owner of a property;
- As sole occupant of a business establishment;
- As an undivided co-owner of a building;
- As a co-occupant of a business establishment.

**No person may be registered in more than one place on the list of electors.**

You may submit a written application for entry, correction or striking off the list of electors to the returning officer if you are domiciled within the territory of the City of Montréal and in one of the following situations:

- You are domiciled or lodged in an eligible health care facility<sup>1</sup>;

This request must be accompanied by copies of two documents: one showing your name and date of birth, the other your name and home address.

If you are domiciled or lodged in an eligible health care facility<sup>1</sup>, these documents may be replaced by an

attestation from a staff member confirming your identity and place of residence. You can contact Elections Montréal to obtain the necessary forms, which must be completed and delivered no later than 6 p.m. on November 28, 2023.

<sup>1</sup> Eligible health care facilities are hospitals, CHSLDs, rehabilitation centres and private residences for seniors registered under the Act respecting health services and social services (chapter S-4.2) and hospitals and reception centres within the meaning of the Act respecting health services and social services for Cree Native persons (chapter S-5) located within the territory of the borough of L'Île-Bizard–Sainte-Geneviève.

### IMPORTANT

In the case of an application for registration from a person domiciled within the territory of the borough of L'Île-Bizard–Sainte-Geneviève, the person making the application to a board of revisors must specify the previous home address of the person whose registration is requested and present two documents identifying the latter, one confirming his or her name and date of birth, and the other his or her name and current home address.

You can consult the list of electors and submit applications for entry, striking off or correction at the Board of Revisors located at 100, Boulevard Jacques-Bizard, suite 120, Montréal, and on the following dates and times:

**Sunday November 26 from 10 a.m. to 6 p.m.**  
**Monday November 27 from 2 p.m. to 10 p.m.**  
**Tuesday November 28 from 10 a.m. to 6 p.m.**
